

Invitation to Bid

Project Name: Construct Taxiways and Apron
Airport: Indiana County Jimmy Stewart Airport
Location: Indiana, Pennsylvania

Sealed bids for furnishing all labor, materials, and equipment and performing all work for the above items will be received by the Indiana County Commissioners until 9:30 A.M. local time, April 25, 2024 at the Indiana County Commissioners Office (825 Philadelphia Street, Indiana, PA, 15701) , then publicly opened and read aloud in the Commissioner’s Hearing Room, 825 Philadelphia Street, 2nd Floor, Indiana, Pennsylvania 15701.

The successful bidder must comply with requirements set out in the contract documents including all Federally Required Contract Provisions including but not limited to the Buy American Preference, Foreign Trade Restrictions, Davis Bacon Requirements, Affirmative Action Requirements, Government wide Debarment and Suspension, Government-wide Requirements for a Drug-free Workplace, and Non- Segregated Facilities Requirements.

Plans, Specifications, and other Contract Documents will be open to the public for viewing at the Indiana County Jimmy Stewart Airport. Plans and Specifications will be available April 2, 2024 and can be purchased in both hardcopy and digital (PDF) formats at <https://bidders.deltairport.com>.

Bids must be accompanied by a certified check or a bid bond in the amount of not less than five (5) percent of the total amount bid. A Contract Performance Bond and a Contract Payment Bond each equal to 100 percent of the Contract Price will be required for the successful Contractor.

No bid may be withdrawn for a period of 60 calendar days after the date of receiving bids, except that bids for any bidder who Consents to Extend Bid Award Date may, at the request of the Indiana County Commissioners, be held for consideration for such longer periods as may be agreed to, but in no event exceeding 180 calendar days.

A Pre-Bid meeting has been scheduled for 1:30 P.M., April 9, 2024 at the Airport Conference Room, 398 Airport Road, Indiana, Pennsylvania, 15701.

In accordance with 49 CFR Part 26, a Disadvantaged Business Enterprise (DBE) Goal for this project has been set to 5.51%. All DBE firms used to meet this goal must be certified by the Pennsylvania Unified Certification Program (PA UCP). Certification as a DBE by the PA UCP is separate and distinct from other certification programs. The only source that should be used for verification of current eligibility of a DBE firm is the PA UCP website at www.paucp.com. Physical certification letters and/or expiration dates should not be requested from DBE firms.

The successful bidder shall commence work with adequate force and equipment on a date to be specified in a written order of the Owner and shall complete work within the time prescribed in the contract documents.

Proposals shall be placed in a sealed envelope addressed to the Indiana County Commissioners Office at 825 Philadelphia Street, 2nd Floor, Indiana, PA 15701.
